Privacy Policy and Intellectual Property notice

The personal data collected in the context of KOVAI INNOVATE Open Innovation Program is processed by NUMA BENGALURU INNOVATIONS PRIVATE LIMITED, a Private Limited Company, incorporated under Companies Act 2013, having Corporate Identification Number (CIN) U74900KA2015PTC083286, whose registered office is located at 46/1, 5th Floor, Cobalt Church Street Bangalore – 560001, India on behalf of SUEZ Projects Private Limited, a Private Limited company, registered under the Indian Companies Act, 2013 whose registered office is located at LGF A-1/132, Safdarjung Enclave, New Delhi -110029, and Corporate Office is located at Unitech Business Park, Second Floor, Tower – A, Gurgaon, Haryana – 122001 (collectively referred to as the “**Data Controller**”)

- Email Address
- Phone Number

- Enrolled Course and course year of the student applicant

Mandatory or optional nature of data collection

The collection of data is necessary for the execution of this processing operation.

Automated decision making

The processing does not provide for automated decision making.

Data subjects

The data processing concerns the participants of KOVAI INNOVATE Open Innovation Program. Only the residents of Coimbatore, India are eligible to participate in this Program.

Data recipients

The personal data collected are exclusively intended for KOVAI INNOVATE steering committee and team.

Data retention period

The personal data collected will be kept for the time required to process: 1 year.
