PHILIPPE MAILLARD IS APPOINTED

CHIEF EXECUTIVE OFFICER RECYCLING AND RECOVERY FRANCE AND EXECUTIVE VICE PRESIDENT RECYCLING AND RECOVERY EUROPE

Philippe Maillard joined the Group in 1993. He has since spent his career, in both water and waste management businesses, in France and abroad. He was appointed Chief Executive Officer of Water France activity in 2011, and then Executive Vice President Water Europe Division in 2013.
