SUEZ ENVIRONNEMENT AND LEND LEASE SIGN A 25-YEAR PFI CONTRACT WITH THE SOUTH TYNE AND WEAR WASTE PARTNERSHIP FOR 825 MILLION EUROS REVENUES*

SITA UK, subsidiary of SUEZ ENVIRONNEMENT, has signed a Private Finance Initiative (PFI) contract worth 825 million euros* over 25 years with the South Tyne and Wear Waste Partnership, representing Gateshead, South Tyneside and Sunderland local authorities. SITA UK formed part of a consortium, which includes Lend Lease and I-Environment Investments Ltd, subsidiary of ITOCHU Corporation. The signing of the contract comes seven months after the SITA Consortium was selected as preferred bidder.

Jean-Louis Chaussade, CEO of SUEZ ENVIRONNEMENT, said: "This is a major PFI contract for SUEZ ENVIRONNEMENT and SITA UK. Thanks to a strong presence and experience in the North East of England, we have worked hard to develop a competitive solution for the Partnership. By recovering energy from residual waste, this project fits well with the Government's aspiration to reduce the amount of residual waste that is landfilled."

The contract is to manage 190,000 tonnes of residual household waste each year. It includes the design, build, finance and operation of an energy-from-waste facility in Teesside with a capacity of up to 256,000 tonnes per year, which will generate electricity for the equivalent of around 30,000 homes. This facility, which already has planning permission and an Environmental Permit, is expected to be operational in 2014. Also included in the contract is the development of three waste transfer stations and a visitor centre. In total over 90 per cent of the contract waste managed by SITA UK will be diverted from landfill.

Dan Labbad, Chief Executive Officer - EMEA, Lend Lease, added: "SITA UK and Lend Lease are extremely pleased to have been appointed to work with Gateshead, South Tyneside and Sunderland local authorities, to help them significantly reduce the amount of waste they send to landfill and increase their recycling rates. Reaching financial close recognises the expertise of the consortium in this emerging market sector."

SITA UK has developed a number of PPP (Public Private Partnership) contracts across the UK including: Surrey, South Gloucestershire, Kirklees, Cornwall, Northumberland, Aberdeen, the Isle of Man and Teesside. In September 2010, SITA UK signed a PFI contract with Suffolk County Council worth £1 billion over 25 years. In the waste sector, this type of partnership was developed to allow British local authorities to develop additional waste management facilities other than landfill.

*total contract value is in excess of 1.2 billion Euros with the addition of revenues from the management of third party waste and sale of electricity
